9. Canworthy Water Solar Farm	<p>A letter from Windel Energy with an expression of interest form explaining the proposed development and consultation was issued to all residents within a 3km radius however Trelash residents did not receive this.</p> <p>Cllr Hutchinson to complete part 2 of the form: <i>We represent group / project located within 3km of the proposed site that could benefit from the fund.</i> We represent the Parish Council and we can allocate the funds accordingly to different Community groups. <i>Are you supportive of this proposal:</i> No because the majority of the people we represent do not agree with this proposal.</p> <p>All in agreement Proposed Cllr Short, seconded Cllr Barton</p>	
10. Correspondence –	<p>Cllr Hutchinson received an email from a resident regarding an accident that had occurred after the Canworthy Water bridge on the corner heading towards Wainhouse, in the early hours. The Parish Council cannot enforce the speed limits however Cllr Hutchinson will report in the Warbstow News that we still require volunteers for Speed Watch.</p> <p>Another resident has contacted Cllr Hutchinson regarding the water run off being red at Wilsey Woods. After taking her dog to this area the dog was subsequently very poorly with Norovirus. Cllr Hutchinson will also report this in the Warbstow News to see if there are other incidents of this kind.</p> <p>Cllr Ireland requested to also advertise in the Warbstow News that dog walkers wear florescent clothing when out during the evenings.</p>

Community Hub	<p>Cllr Hutchinson reported that Nick Heritage is the new treasurer.</p> <p>There will be a defibrillator refresher course being held at the Community Hall on the 20th April at 2pm, everyone welcome. As this course is being held for the community it was requested that this fee be waived but unfortunately this was not possible. Oliver Jones suggested putting up a sign saying ‘Welcome to our village, please drive carefully’</p> <p>Cllr Hutchinson to go back to Oliver Jones regarding the post entering Canworthy Water from Jacobstow and Warbstow from Fonston being situated under the trees. She will also request a quote for the Lane End and Trelash village signs.</p>
